### **Expert Workshop: Measuring the impact of interventions aiming to prevent violent extremism**

#### **Purpose of the workshop**

This workshop will bring together experts, UNDP staff and partners in order to improve the UNDP approach to monitoring of PVE projects, as well as provide a forum for exchange among those working in the field of PVE.

#### **Objectives**

1. To share experiences of challenges and successes in design and M&E of PVE projects.
2. To improve approaches to M&E of PVE projects through a co-design process.

#### **Methodology**

Participants will be invited to engage on the critical issues in this field and explore elements of the draft UNDP approach to M&E to see how far it is able to support the monitoring of PVE outcomes. This will enable the identification of gaps and needs. Participants will draw on their expertise to engage in a co-design process to support the building of new tools and/or improvement of existing approaches for the monitoring of PVE activities.

<b>Session 2</b>	<p><b>Background and approach to the development of the monitoring framework and tools.</b></p> <p>An overview of the background to how this process emerged, the approach adopted by the Regional Hub and the ways in which the Hub will continue to support monitoring around PVE programming.</p>
<b>Session 3</b>	<p><b>Framing the challenges:</b></p> <p>Drawing on the research from the global review of monitoring approaches to PVE, conducted under this project, together with consultations held with UNDP Country Offices, this session will explore some of the key challenges around monitoring of PVE. An outline of the proposed monitoring framework and tools will be presented – elements of which will be unpacked over the next two days of the workshop.</p>
<b>Session 4</b>	<p><b>Exploring approaches to Theories of Change (ToC) for PVE.</b></p> <p>This session will highlight some of the common problems around ToCs for PVE and propose an approach to addressing these problems. Working with case studies, participants will ‘test’ the approach, evaluating its applicability against different contexts and proposing adaptation.</p>

<b>Session 5</b>	<p><b>Feedback from Session 4</b></p> <p><b>Panel Discussion: Identifying, understanding and programming for risks around PVE.</b> This panel will explore in depth the expected and unexpected risks around programming in PVE.
